Definicija:

- otvoren (besplatan) pristup naučnim informacijama
- radikalno nov ekonomski model naučnog publikovanja



Open Access

Razlozi

- povećanje dostupnosti naučnih informacija, i time ubrzavanje naučnog razvoja
- istraživanja su većinom finansirana javnim sredstvima...javno dobro
- umanjenje (globalno) ukupnih troškova diseminacije

 - zlatni - APC Article processing Charge
 - finansijer preko autora plaća
- repozitorijume (institucionalne, tematske,...)
 - zeleni

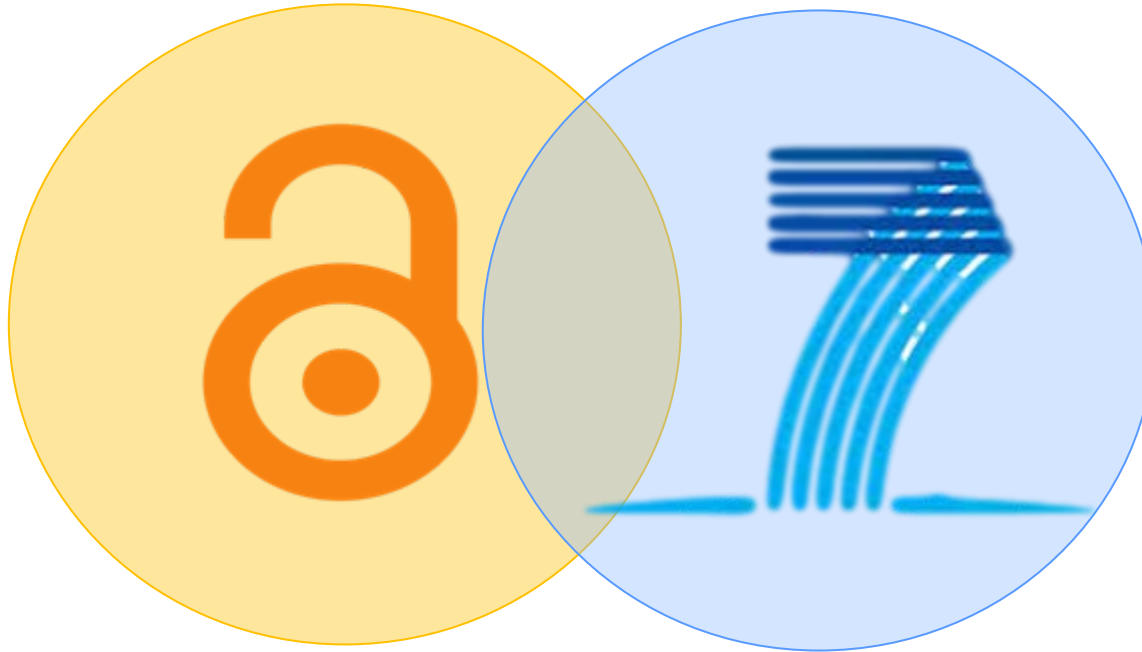

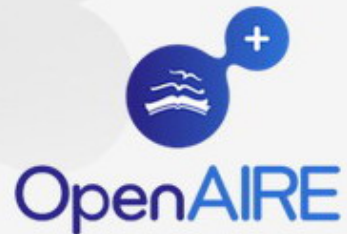

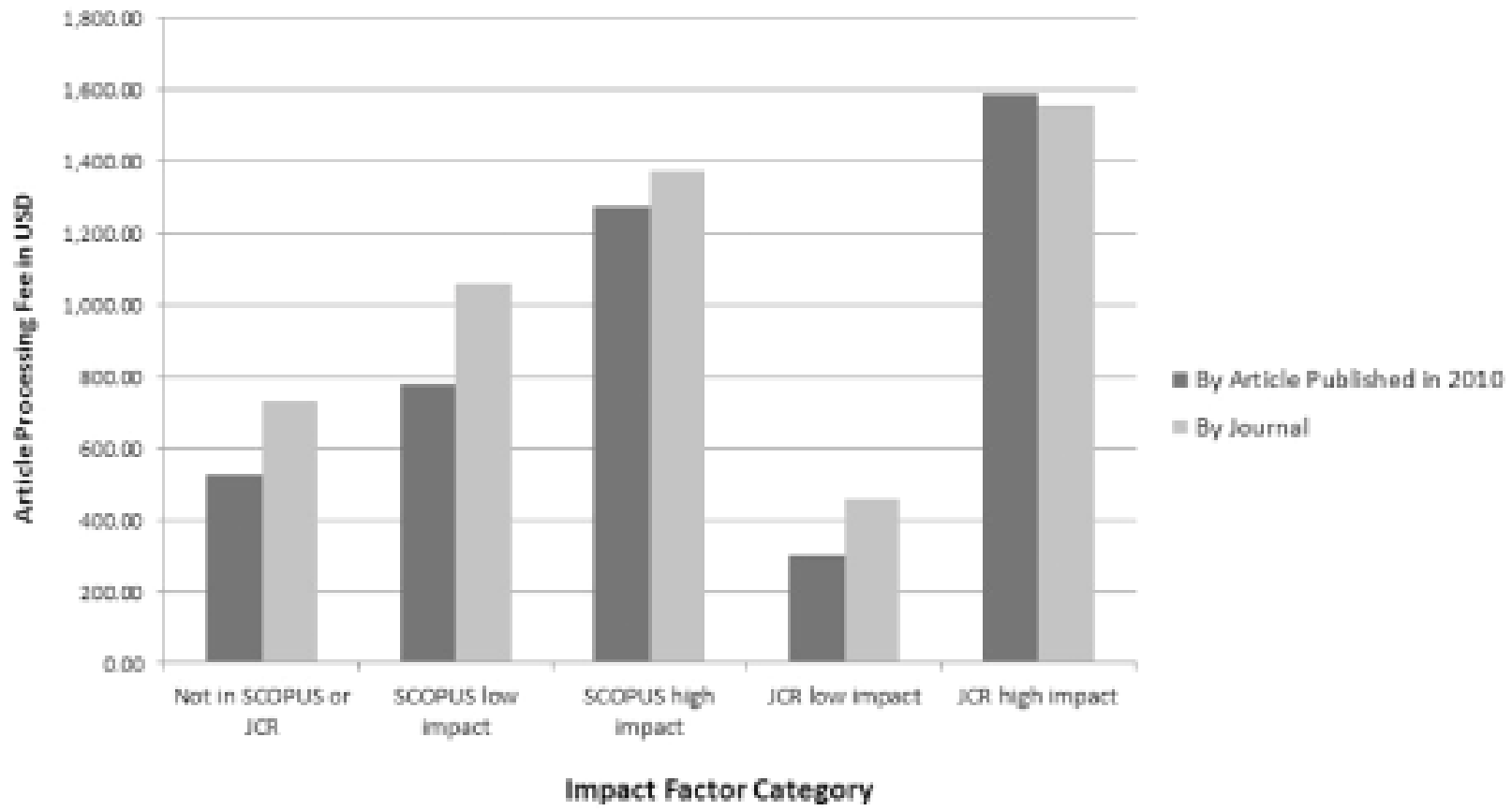
